Explanation of Responses:

1. The Restricted Stock Units ("RSUs") issued pursuant to the Simon Property Group, L.P. 2019 Stock Incentive Plan will vest ratably over a two year period: half on January 1, 2023; and half on January 1, 2024. Vested portions of the RSUs will be settled in shares of Simon Property Group, Inc. (the "Company") common stock as soon as practicable after the vesting date, subject to a continued service requirement, or may vest and settle earlier due to the Reporting Person's death or disability, a change of control of the Company, the retirement of the Reporting Person, subject to the approval of the Company's Compensation Committee, or as may otherwise be determined by the Company's Compensation Committee in accordance with the terms of the grant agreement and the Plan.

2. Each RSU represents the contingent right to receive, at settlement, one share of common stock of the Company.
